# Make an Informed Choice: Preparing for Electricity Pricing Changes

On November 1, 2009, long term care homes along with municipalities, schools, hospitals and other designated customers will no longer be eligible for the government's Regulated Price Plan (RPP) for electricity. This means that organizations currently on the RPP will be required to move to market pricing through their utility (hourly electricity price or a weighted average price) or purchasing electricity through a retail contract with a marketer.

To assist members in preparing for this change, OANHSS, the Independent Electricity System Operator (IESO), and Natural Resources Canada are partnering to provide information on the electricity market and energy management opportunities.

Building on previous OANHSS education on electricity pricing and supply options, this workshop will be an opportunity to share insights from the recent energy interviews and audits the IESO conducted with members. Other key areas that will be addressed include energy management, reducing consumption and costs, and energy incentives and opportunities.

This full-day session will cover:

- The importance of managing energy.
- The role of staff in reducing energy consumption and costs.
- Calculating the financial value of energy efficiency projects.
- Low cost / no cost ways to save.
- How to monitor electricity and gas consumption.
- Results from the IESO/OANHSS energy project.
- EcoEnergy financial incentives.
- Building an effective business case for energy projects.
